Items for 96th CEG:

1. Tree Trimming at the following addresses is needed – 131 Dixie Road, 133 Dixie Road, 306 Chisk Lane, 514 DeSoto Circle. Recommend the entire area be reviewed and trimmed as necessary. Responsible for action – 796 CES; Target date for completion – 16 Jun 03.
2. The playground near 401 Dixie Road needs repair/replacement. Responsible for action – 796 CES. Recommend Engineering investigate and determine extent of repairs and/or replacement, then plan the appropriate repair/replacement action. Target date for plan of repair/replacement action – 11 Jun 03.
3. What happened to the Mobile Home Park sign? – Responsible for action – 796 CES; Target date for completion – 30 May 03.
4. Mobile Home Park Briefing slides posted on EMIS – Responsible for action – 96th CEG/CEMW&CERP; Target date for completion – 29 May 03.
5. Newsletter or website for information on Mobile Home Park Closure – Responsible for action – 96th CEG/CEMW&CERP; Target date for implementation of website – 31 July 03. Legal, Public Affair, Traffic Management Office, Funds Management, CEG, Air Base Wing, and Base Information Assurance Office must approve all information posted.
6. If the mobile home is deemed to not be road worthy, how will the mobile home be moved, disposed of or otherwise removed from the park? – Responsible for action – 96th CEG; Target date for completion – 16 Jun 03.
7. Meet with and/or discuss with community leaders the park closure and possible partnering – Responsible for action – 96th CEG; Target date for contact completion – 18 Jun 03.
8. List of Mobile Home Parks in the area – Responsible for action – 96th CEG/CEMH; Target date for completion – Partial list is available at the Housing Office. List to be expanded to all parks within 50 miles by 18 Jun 03.

Items for AAC/FM:

1. Why does the AF pay partial DLA? – Responsible for action – AAC/FM. Answer provided as follows:

U5600 PURPOSE The purpose of DLA is to partially reimburse a member, with or without dependents, for the expenses incurred in relocating the member's household on a PCS, housing moves ordered for the Government's convenience (see par. U5630-B15), or incident to an evacuation (see pars. U6012 and U6059). This allowance is in addition to all other allowances authorized in this Volume and may be paid in advance (37 U.S.C. §407).

U5630 FACTORS AFFECTING ENTITLEMENT

B. Special Categories Where DLA Authorized

15. Housing Moves at a PDS for Government Convenience. A partial DLA of \$523.50 (effective 1 January 2003) must be paid to a member who is ordered to occupy/vacate Government family-type quarters due to: a. privatization, b. renovation, or c. any reason other than PCS. NOTE: Partial DLA is not authorized for those local moves from Government quarters upon separation/retirement.
