SUBJECT: Hurlburt Field and Eglin AFB Off-Limits Restriction Announcement

1. In accordance with EAFB 31-213, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations, the following establishments have been deemed off-limits to Armed Forces personnel and shall remain in effect until issuance of an updated notice:

Military personnel (whether in uniform or civilian attire) found entering, leaving or conducting business with any of these establishments may be subject to disciplinary actions under the Uniform Code of Military Justice.

Copies of this notice should be publicized through First Term Airman Center (FTAC) briefings, Base Newcomers briefings, the base papers, and posted on bulletin boards and other high-traffic locations throughout the base.
